

STUDENT CONDITIONS OF USE FOR YUNGGORENDI MANDE FACILITIES

The Office of Indigenous Strategy & Engagement provides facilities within Yunggorendi Mande to support Indigenous Australian students during their period of study at the University. Facilities include:

- Tjilbruke Student Lounge, Level 3 (computers, printer, lounge/quiet study area and kitchen. Indigenous Student Support Officers and a Program Support Officer are co-located in the space and available 9am to 5pm each weekday; also onsite is a Study Skills Advisor (Monday, Wednesday and Thursday) and an Indigenous Counsellor on Tuesdays;
- 2. Yunggorendi Tutorial Program (YTP) tutoring spaces are located on:
 - Level 3, Room 3.13 (when not in use by Study Skills Advisor or Indigenous Counsellor) not available after hours;
 - Level 2, Room 2.13 Tutorial Room not available after hours;
 - Level 1, OIS&E Meeting Room 1.07, for group work, presentation preparation.

Twenty-four hour access to facilities is available to students who complete this application, have had their Proof of Indigeneity form accepted by OIS&E, and have consented to the following conditions of use.

Students who require tutoring spaces can book the OIS&E meeting room (1.07) and Tutorial Room (2.13) through reception. Access expires as at 31 December and students are required to reapply at the beginning of each semester 1.

TJILBRUKE STUDENT LOUNGE

The Tjilbruke Student Lounge is a shared space for all Indigenous Australian students studying at Flinders to use. It provides a kitchen, television, lounge, computers and a printer. It is not a formal study space and therefore must accommodate the various needs of multiple users. Please note that during office hours OIS&E staff are co-located in offices within the space.

The Tjilbruke Student Lounge offers access to facilities, including computers to support Indigenous students with their studies. The use of these facilities is governed by Flinders University's
